VACANTIABANDONED PROPERTY REGISTRATION FORM

Registration is required for all vacant and abandoned buildings, whether secured, open or boarded. The requirements are applicable whenever any building or structure, whether governmental, commercial, institutional or residential, or owned by a nonprofit or for-profit organization, has remained vacant or abandoned for more than forty-five (45) days. This also applies to any building or structure, whether residential or commercial, which does not have a valid Certificate of Occupancy issued by the City of Hazleton's Code Enforcement Office. In no instance shall the registration of a vacant or abandoned building exonerate the owner, agent or responsible party from responsibility for compliance with any other applicable code(s). One registration form may be filed to include all vacant and abandoned buildings of the property owner. A non-refundable fee of one hundred (\$100.00) dollars per building or structure must accompany this registration form. This registration form must be filed and payment received on or before November 15th of each year.

The failure or refusal of any owner or agent/representative of an owner, to file a registration statement or to pay any required fees within thirty (30) days after notice, constitutes a violation punishable upon conviction thereof by a fine in the amount of not less than five hundred (\$500.00) dollars nor more than one thousand (\$1,000.00) dollars for the first two continual and uncorrected failure or refusal to register, or for each failure or refusal to pay, and not exceeding five thousand (\$5,000.00) dollars for the third and any subsequent failure or refusal to pay, or imprisonment for any term not exceeding ninety (90) days or both. Unpaid fines will be registered as a lien against the violating building or structure.
